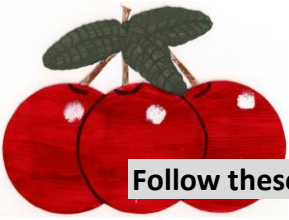

Parade Rules

1. To ensure excellence in presentation and efficiency in coordination, placement within the parade line-up is at the discretion of the Cherry Fair Parade Coordinators.
2. Parade line-up begins at the Artesian Blue Water Plant at 9:00 a.m. For walking participants, line-up is at the Methodist Church parking lot. Parade starts at 10:00am.
3. Your safety is our first priority. Per our insurance policy guidelines, parade participants may not THROW any items from their entry. If you wish to hand out candy along the way, you may have someone walking alongside your entry to hand out candy, balloons, flyers, etc.
4. Because there are no fees charged or a budget established for participating in the parade, *there may be no restrooms* at the line-up area.

1. **Completed the Parade Application Form, and make a copy for yourself.**
2. **Read and sign the agreement below:**

Participation Agreement: I/we certify to have read and understand parade rules pertaining to the Cove Cherry Fair Parade and agree to abide by all.
